


Management systems of trade association memberships and lobbying activities related to climate change

B.Grimm Power is committed to achieving net zero carbon emissions by 2050, aligned with the Non-OECD 2°C net zero pathway and the goals of the Paris Agreement. We recognise the importance of transparent and responsible climate policy engagement, and the role of trade associations, and environmental partnerships in supporting these goals. This disclosure outlines our participation in the management systems of trade associations and environmental partnerships to ensure consistency with our climate commitments. The program covered operations in Thailand, representing 92.2% of total revenue in 2024.

Governance structure and framework

We have a robust governance framework for public policy engagement with clear accountabilities up to the executive level.



Review & monitoring process with criteria

B.Grimm Power will conduct a thorough evaluation of its association memberships to determine their relevance to the climate position alignment assessment against the Paris Agreement

1. Identify relevant trade associations

Key selection criteria to identify relevant trade associations and environmental partnerships include:

- The association's focus on the energy sector, particularly electric utilities, renewables energy and industrial sectors
- 2) The association's influence on public climate policy
- 3) The association's direct engagement in climate change initiatives
- 4) Alignment between the association's activities and B.Grimm Power's significant operational areas.

Assessment Methods

- Site visits: conduct visits to gather firsthand information.
- Social media research: search for and analyse information disclosed on social media.
- Member discussions: engage in discussions with member representatives.
- Questionnaire surveys: distribute and analyse questionnaire surveys for feedback.



Results and actions

We have established a framework for addressing any misalignments between the climate change policy positions of trade associations and our own climate position:

- For associations not aligned with our climate position and the goals of the Paris Agreement, we will initiate
 open dialogue and work collaboratively to drive and support activities or actions to bridge the gap over a
 two-year period.
- If alignment cannot be achieved, we may re-evaluate our membership while maintaining the possibility for future collaboration.

B.Grimm Power applies a review and monitoring process to all direct lobbying activities to ensure alignment with our climate commitments and the Paris Agreement. Prior to engagement, activities are assessed for consistency with our net zero targets. Post-engagement, outcomes are documented and reviewed at least annually by the Climate Taskforce and reported to the Management Committee. In cases of misalignment, appropriate actions such as revision of engagement strategy or discontinuation are considered. Examples of our climate-related direct lobbying and trade association activities are as follows:

- As a member of the Association of Private Power Producers (APPP), B.Grimm Power actively promoted dialogues and policy advocacy related to clean energy supply through public-private mechanisms. In collaboration with Thailand Development Research Institute (TDRI), APPP initiated a study to explore pathways for enabling private power producers to supply clean electricity to industrial operators in the Eastern Economic Corridor (EEC) through new grid infrastructure. These efforts aim to unlock opportunities for distributed renewable energy and support national decarbonization goals.
- We actively monitor and provide feedback on national climate-related regulatory development, including
 participating in public hearings and consultations on the Climate Change Act. We contributed perspectives and
 recommendations representing the power generation sector to ensure feasibility, technical readiness, and alignment
 with climate ambition.
- We signed a Memorandum of Understanding (MoU) with the Office of Natural Resources and Environmental Policy
 and Planning (ONEP) to collaborate on biodiversity conservation. The partnership enhances our long-term
 contribution to ecosystem protection and climate adaptation.



 B.Grimm Power showcased our biodiversity initiatives at the 12th Conference on Taxonomy and Systematics in Thailand under the theme "Biodiversity for Wealth and Sustainability." The exhibition highlighted our commitment to integrating biodiversity into climate-related corporate actions.

In addition to our formal memberships, B.Grimm Power actively contributes to non-paid but influential networks that support national and global Net Zero goals. We are a member of the Thailand Climate Business Network (ThaiCBN), B.Grimm Power serves as a key representative for the energy sector, helping coordinate climate strategies among private power producers to align with national and international climate goals. We also participate in the SET ESG Experts Pool, a network of sustainability professionals under the Stock Exchange of Thailand, which supports knowledge sharing and policy dialogue on sustainability and climate strategy across sectors.

These activities highlight our strong commitment to addressing climate change and climate strategy, while also recognising that the conservation of natural forests and wildlife plays an essential role in building climate resilience and protecting our planet's ecosystems.
